The Trustees of the Charity for the purposes of the Companies Act 2006, present their report with the financial statements of the Charity for the year ended 12 September 2013. The trustees have adopted the provisions of the Statement of Recommended Practice (SORP) 'Accounting and Reporting by Charities' issued in March 2005 as amended in 2008.

INCORPORATION

The Charity was incorporated as a limited liability company on 04 February, 2011 and was registered as a charity by the Charity Commission on 13 September 2011 The Charity began trading on 13 September 2011.

GOVERNING DOCUMENT AND CONSTITUION

The Charity is governed by and its constitution is its Memorandum and Articles of Association.

TRUSTEES SELECTION

All Trustees since incorporation were appointed by resolution of the existing Trustees. Any new Trustees will be appointed by the existing Trustees.

THE OBJECTS OF THE CHARITY

- 1. To record for posterity and to promote the care of those memorials, monuments, buildings and other marks of remembrances testifying to the presence of Poles in the United Kingdom.
- 2. To record and promote the contribution of Polish social organisations and individuals of Polish origin in the United Kingdom to the cultural heritage of the United Kingdom
- 3. To advocate, preserve and promote the strong historical relationship between the British and Polish nations through greater awareness amongst present and future generations of British citizens of the historical links between the two countries by publishing widely its activities in the public domain.
- 4. To co-operate in a non-political, transparent manner with any groups, associations, societies and bodies, public and private, and with individuals in the common interest of the maintaining and protecting our common Polish heritage in the United Kingdom.

MAIN ACTIVITIES, ACHIEVEMENTS AND CHALLENGES DURING THE YEAR

1. Ognisko Polskie Renovation Project

October-November 2012

After an active role in helping prevent the sale of the Polish Community's iconic building in Kensington, Ognisko Polskie (The Polish Hearth), 2012, the Chairman of the Polish Heritage Society agreed with the Board of the Society to pay for and manage the renovation of the front façade of the building.¹ The Building is a Grade 2 listed building that is subject to English Heritage Guidelines.

This donation represents the Polish Heritage's largest donation to date and the largest donation received by Ognisko Polskie (The Polish Hearth) in recent years.

2. Joseph Conrad Exhibition

November 2012

Polish Heritage Society was delighted to be able to support The Polish Library, based in POSK, to prepare its Joseph Conrad exhibition November 2012. Joseph Conrad is one of Poland's most recognisable authors outside the borders of Poland. Many of the items on display came from his study from his house in Kent.

3. Arnhem Film Premier, Embassy of the Republic of Poland

November 2012

Jointly promoted with the Polish Embassy. 'A Debt of Dishonour' shows a fresh insight into the role of Polish Forces under General Sosabowski and his leadership capabilities during 'Operation Market Garden'. In attendance were the Deputy Head of Mission, Minister Counsellor Mr Darius Laska, Mr Michael Sosabowski, the grandson of General Sosabowski and Colonel Mike Russell, Commanding Officer of Aldershot Garrison.

4. Arnhem Film Premier, POSK, London

November 2012

A screening was held for a mainly Polish audience. The film was preceded by a contextual introduction into Arnhem and Driel 1944 battles and was followed by a lively question and answer discussion.

5. General Sosabowski Plaque

February 2013

A plaque to mark the house where General Sosabowski lived was erected in Chiswick, London W4. The unveiling was attended by Mr Michael Sosabowski, grandson of General Sosabowski, the Military Attache and the Deputy Head of Mission of the Embassy of the Repubic of Poland.

6. Arnhem Film Premiere, Manchester

March 2013

The Screening was in the presence of the Consul General in Manchester, Mr Lukasz *Lutostanski*, and attended by a large British and Polish audience that included a large contingent of the British Legion and UK Association of the Airborne Forces.³

7. Arnhem Film Premiere, Centre for Jewish Culture, Krakow May 2013

The screening took place as the result of a direct invitation of the Centre Director.

8. Arnhem Film Premiere, Warsaw Rising Museum

June 2013

The Polish premiere of 'Arnhem – A Debt of Dishonour', presented by the Chairman of Polish Heritage Society was held at the Warsaw Rising Museum in the Liberator Hall. The Premiere was attended by a large audience including a number of prominent VIPs.

9. Marie Curie Hospice and Dr A Meeson Kielanowski

January 2013

Marie Skłodowska-Curie was a Polish physicist and chemist. She was the first woman to win a Nobel Prize, and the only woman to date to win the Nobel Prizes in two separate fields (Physics and Chemistry). In 1995 she became the first woman to be entombed on her own merits in the Pantheon in Paris.

The Society presented a bronze bust of Marie Curie Sklodowska to the Marie Curie Hospice in Hampstead on 23rd January 2013 to celebrate the life and work of Dr Andrew Meeson Kielanowski, one of the founders of the Polish Heritage Society and well known in medical circles in Hampstead. The bust was unveiled by his widow Mrs Anita Meeson Kielanowska, on the first anniversary of Dr Meeson Kielanowski's death.

10. Joseph Conrad Society

May 2013

The Polish Heritage Society has set up a 5 year Bursary programme for the Joseph Conrad Society. In year two, this was awarded to Ms Stanek, studying at University of Surrey. The bursary went towards Ms Stanek's attendance at a Joseph Conrad Conference being held in Rome.

11. Krystyna Skarbek/Christine Granville

May 2013

A major project for the Polish Heritage Society who renovated the grave of Christine Granville, nee Krystyna Skarbek, at Kensal Green Cemetery in North London and positioned a plaque in St Mary's Church, Kensal Green Cemetery to commemorate her life. A service was celebrated by The Right Reverend Alan Hopes, Auxiliary Bishop of Westminster, (currently the Bishop of Norwich and East Anglia), in the presence of The Ambassador of the Republic of Poland, H E Witold Sobkow, Maj.Gen. John Drewienkiewicz, the Mayor of Kensington and Chelsea, as well as British and French Militaries.

The event attracted international press and media coverage of this famous SOE 'Spy' and subject of many books, such as Clare Mulley's 'The Spy Who Loved'. A celebration lunch was held in POSK.

12. The Polish Heritage Concert

May 2013

To raise funds for future projects within the Polish Community and to thank supporters throughout the year, the Polish Heritage Society held an evening of popular classical music, followed by a buffet dinner, courtesy of the Embassy of the Republic of Poland on 23rd May 2013.

This was the first event of this type and it was sell out! Mark Dowd played Chopin and the soprano sang arias from, the highlight of the evening Cheryl Enever singing in Polish, a song based on Chopin's music.

Polish Queens Honours

The Polish Heritage Society has carried out an analysis of all official honours³. We have identified 182 Polish surnames which, between them, received 186 official Civil Honour Awards (1946 – 2013). This includes 5 Knighthoods as well as 5 individuals who received 2 honours each. The most popular awards included 89 MBE, 46 OBE, 18 BEM and 15 CBE. We also identified 68 Polish surnames which received 83 official Military Honour Awards during this same period. The highest level of awards were given to the Polish officers in the RAF (63), Army (17) and the Royal Navy (3). In addition, we also identified 76 Polish surnames in the Debrett's List, with the highest levels being 19 University Professors, 14 Lawyers, 14 Artists, 9 Medical Doctors & 9 Journalists.

General Elections – Polish Candidates & MPs

The Polish Heritage Society carried out a detailed analysis of every single election since June 1945 (18 General Elections and 489 By-Elections to 01 July 2013)⁴. 69 Polish candidate surnames appeared in 10 General Elections since 1970, the most being Labour (15 candidates), Liberal Democrats (13), Conservative (9), Liberal (8) and UKIP (6). To date, there were 5 elected Polish MPs (3 Labour MPs including Denis MacShane [Matyjaszek], Marek Lazarowicz and Simon Danczuk as well as 2 Conservative MPs including Stefan Terlezki and Daniel Kawczynski). The most successful MP (to date) has been Dennis MacShane who was elected on a By-Election (05 May 1994) and has subsequently won his re-election in the last 4 General Elections.

Polish Links

The Polish Heritage Society has created numerous Recommended Links which have been sub-divided into 5 major categories: Polish Museums (3 links), Polish Clubs (2), Polish Interest (8), Polish Air Force WW2 (8) and Polish Army Records in UK (1). Most of these links are based upon website addresses of Polish-related cultural and social UK-based institutions but, in addition, the majority of the military links include original films of the WW2 as well as the longest known list (20,000+/689 pages) of Polish airmen who served in the RAF in WW2.

14. Candles on Graves November 2012

The Polish Heritage Society has been active in continuing the tradition of commemorating All Saints Day on 1st November, by placing candles on the graves of well known personages in various cemeteries. The Embassy of the Republic of Poland has been supportive of organisations continuing this tradition.

15. Register of Polish Heritage Project

2013

The Polish Heritage Society has what it hopes might be become a community wide project - a Register of Polish monuments, important buildings, plaques and other evidence of Polish Heritage in the United Kingdom. We encourage all walks of the Polish Community to work together to compile a unique and inclusive document for our future generations.

Independent examiner's report to the trustees of Polish Heritage Society (UK) Limited

I report on the accounts of the company for the year ended 13 September 2013, which are set out on pages 7 to 9.
